RULES GOVERNING NORTHERN CONFERENCE PROCEDURE- AND STANDING ORDERS 2025

1. Northern Conference is a Regional Conference (under Rule 21 of the Rules and Constitution) for the purpose of deciding questions of concern only to members in Northern Ireland.
2. Northern Conference is constituted as follows:
 - a) Northern Committee members.
 - b) Members of the Central Executive Committee and Benefit Funds Committee.
 - c) the Northern Conference SOC which shall consist of three members each from districts I and II elected in accordance with the terms of Rule 72;
 - d) Two delegates each from District I and II.
These delegates shall be members of their District Committees.
 - e) Delegates from Branches in accordance with the following scale:

Branch Membership	No. of Delegates
129 and under	2

with an additional delegate for each additional 65 members or part thereof. Delegates must members of the branch, which they are appointed to represent and qualified in accordance with Rules 75 and 76 or 77.
3. Northern Committee is responsible for arrangements for Northern Conference.
4. At the June meetings, District Committees I and II shall elect from their membership three representatives each to serve on the Standing Orders Committee [SOC]. At the first meeting of the SOC, the committee shall choose from among its members a Chair and Secretary. The duties of the SOC are:
 - (i) To prepare the list of motions to be discussed at Northern Conference.
 - (ii) To draft composite motions, amendments and addenda for submission to Northern Conference.
 - (iii) To arrange an order in which motions may be taken and to make such arrangements as they deem necessary. And
 - (iv) To decide what urgent motions (if any) shall be brought before Conference.
5. The Northern Secretary shall issue to Branch and District Secretaries not later than 31 January 2025 a preliminary agenda which shall contain:
 - (i) The rules governing Conference procedure and standing orders.
 - (ii) Motions to be submitted to Conference.
6. Amendments or addenda to motions appearing in the preliminary agenda may be submitted by Branches or District committees and must reach the Northern Secretary not later than the 5 February 2025 (at 5pm). Each amendment must be signed by the secretary of the Branch or District Committee. Northern Committee has the right to submit amendments to any motion appearing on the preliminary agenda.

7. The final agenda shall be sent to delegates to reach them at least three days before the opening day of Conference. It shall contain:
 - (i) The matter in the preliminary agenda.
 - (ii) The annual report of the Northern Committee.
 - (iii) Amendments and addenda to motions appearing in the preliminary agenda.
 - (iv) Names and Branches of delegates to Conference.
8. Urgent matters not on the agenda can be introduced at Conference only when permission to do so has been obtained in the first instance from the SOC. Should this committee by a two-thirds majority grant permission for the introduction of any such motion, its Secretary shall immediately inform the Presiding Chair, who shall thereupon, with the consent of Conference, fix a suitable time for the introduction and discussion of any such motion. An "urgent matter" is deemed to be a matter of vital importance arising in the interval between the closing of motions and the time during Conference at which permission to introduce it is sought.
9. At the commencement of Conference two tellers shall be elected by the delegates. The duty of the tellers shall be to ascertain and report to the presiding Chair the number voting for and against a motion on which a poll is taken.
10. Twenty members constitute a quorum.
11. The following is the order of debate:
 - (i) Subject to the discretion of the Presiding Chair, the **proposer** of a motion shall be allowed not more than **5 minutes**, the **second** **3 minutes**, and each succeeding **speaker 3 minutes**, and **discussion** on any one motion shall be **limited to 20 minutes**.
 - (ii) Speakers to each section of the Northern Committee Report shall be allowed to speak once and for not more than 3 minutes to each section of the report.
 - (iii) Whenever an amendment is moved to any motion, no other amendment shall be taken into consideration until the first amendment is disposed of.
 - (iv) The decision of the Chair on any question shall be final.
 - (v) No delegate shall be permitted to speak more than once on the same proposition except the proposer of a motion who shall have the right to reply.
 - (vi) No person shall address Conference until called on by the Presiding Chair. Before addressing Conference s/he shall first announce their name and the Branch or Committee s/he represents. When a delegate is called upon by the Chair to speak all other delegates shall at once be seated.
 - (vii) Only the delegates may address Conference except by special permission of the Chair.
 - (viii) When the Chair rises to speak all the delegates shall immediately take their seats.
 - (ix) Every motion shall be decided by a show of hands unless a division thereon is demanded. Delegates only have the right to vote. No division shall be taken unless the decision is announced by the Chair after a show of hands is challenged by at least ten members who shall express their desire that a division should be taken by rising in their places. In case of a tied vote the Chair has the casting vote.

- (x) At any time during the discussion of a motion or amendment, it is open to any delegate to move without debate, "that the question be now put", and if it should appear on a show of hands that a majority of the delegates are in favour of terminating the discussion, the question shall be put to a vote, and the decision of Conference taken without further discussion, provided that no speech is interrupted for the purpose and the proposer of the motion is not denied the right to reply. The acceptance of the motion, "that the question be now put" is at the discretion of the Presiding Chair.
- (xi) In the event of a proposition, "that the Conference proceed to the next business" being proposed and seconded, all further discussion on the matter shall cease until this proposition is put to a vote. If the proposition is carried, the motion, and amendments (if any) shall be deemed to have been disposed of and the next business shall be taken up; if defeated, the discussion on the motion and amendments (if any) shall be resumed.
- (xii) Where a motion is divided into sections, all sections shall be voted on separately.

CONFERENCE GLOSSARY

- A **Motion** is a proposition submitted for discussion and vote. It must be positive in its wording and declare an opinion or call for a course of action – or both.
- A **Resolution** is a Motion which has been put to the vote and carried. When a Motion is before Conference an Amendment is a proposition to change the words of the Motion as a whole, or to change certain words, or to add or delete words anywhere in the Motion.
- An **Addendum** is a proposition to add words at the end of the Motion.
- **Reference Back** is a proposition against a report which is under discussion and may refer to the whole report or a section of it. It means that Conference does not approve of the report.
- **To Move** that the question be now put, means that the discussion should cease, and the vote should be taken on the Motion (or Amendment if any) which is before Conference.
- **Moving Next Business** means that the meeting should immediately proceed to the next item of business. It can be moved at any time in reference to the item under discussion, but if it is moved and carried whilst a Motion or an Amendment is under discussion it dismisses the Motion and Amendment without any vote being taken on them. If Next Business is not carried, then Conference resumes discussion on the original Motion and Amendment and, thereafter, takes the vote on them in the usual way.

PUBLIC SESSION MOTIONS

MOTION 1

Conference:

1. commends the commitment of NITC negotiators in their efforts to secure adequate pay awards for teachers in the North;
2. notes the financial impact on members caused by delays in agreeing and funding pay awards.
3. calls on NC, to work through NITC to:
 - (i) continue to seek pay awards that reflect the true value of teachers and school leaders to society
 - (ii) seek an agreed timetable for requiring pay uplifts for teachers and school leaders, when the appropriate financial situation allows.

MOTION 2

Conference:

- a) notes with concern, the lack of transparency and effective communication of the current Minister of Education,
- b) deplores the failure of the Minister of Education to prioritise and address some key educational issues and
- c) calls for a vote of no confidence in the Minister of Education.

Belfast West Branch

MOTION 3

Conference:

- a) utterly condemns the ongoing genocide in Gaza and attacks on Palestinians in the West Bank, and the resultant destruction of the Palestinian education system and denial of the right to education to Palestinian children and young people
- b) commends
 - (i) Irish civil society, and the trade union movement in particular, for the tremendous solidarity shown to the Palestinian people during this horrific period
 - (ii) the INTO Palestine Ambassadors Group, Global Solidarity Officer and NC for continuing to highlight this issue
 - (iii) the many INTO Branches and Districts which have declared themselves Apartheid Free Zones and which continue to highlight the issue of solidarity with the Palestinian people
- c) endorses
 - (i) a key message of the INTO-organised Conference on the Rights of Palestinian Children that the Boycott Divestment Sanctions policy is key to defeating apartheid in Palestine
 - (ii) the ICTU call for the immediate enactment of the Occupied Territories Bill
 - (d) instructs NC to continue to campaign, nationally and through the European Trade Union movement, for EU funding to be made available to support the re-building of the Palestinian education infrastructure under Palestinian control.

MOTION 4

Conference notes:

- a) That excessive workload is a major factor contributing to teacher stress and burnout as well as to teacher recruitment and retention.
- b) That administrative workload is detracting from core responsibilities such as lesson planning, classroom teaching and providing individual support to pupils.

Conference believes:

- a) That reducing workload is essential for improving teacher well-being
- b) That unnecessary bureaucracy and over assessment must be addressed to enable teachers to focus on their primary role as educators.
- c) That a collaborative approach involving all educational stakeholders, including unions, is necessary to create meaningful solutions.

Conference calls on NC:

- a) To maintain pressure on DE and other relevant bodies in their timetable of review of teacher workload.
- b) To advocate for increased investment in staffing, resources and digital tools to alleviate pressure on classroom teachers.

- c) To call on school leaders to prioritise staff well-being by reviewing internal practices, streamlining processes and ensuring realistic expectations for staff.
- d) To promote practical resources and training for members on managing workload effectively and safeguarding their wellbeing.

 - 1. A review of proposed paperwork, assessments, and procedural timelines
 - 2. Procedural frameworks that support, not hinder, the personalised approach to SEN support.
 - 3. Investment in appropriate teacher professional development.

MOTION 6

Conference:

- a) Notes
 - (i) the high rates of mental ill health and trauma amongst children and young people in the North of Ireland,
 - (ii) the increasing demand for teachers to provide support to children with mental health needs,
- b) Further notes that teachers are not trained mental health professionals whilst acknowledging that EA presently provides trauma-informed practice training for schools as a self-directed training video.
- c) Calls on Northern Committee through NITC to:
 - (i) campaign for appropriate training in mental health awareness and intervention for the teaching workforce of NI,
 - (ii) campaign for fully resourced and signposted mental health supports that students can be referred to by schools,

- (iii) engage with EA to develop more appropriate trauma-informed training and support across all educational settings.

- b) Calls on Northern Committee working through NITC to lobby DE to ensure that all teachers receive an individualised Directed Time Budget before the beginning of each new academic year.
- c) further calls on Northern Committee to engage with Northern office to update communication on Directed Time Budgets to ensure members have a clear understanding of the workings and benefits of DTBs.

- b) Calls on Northern Committee to work through NITC to review the pupil teacher ratio in all educational settings and ensure a fair and balanced workload for all teachers.
- c) Calls on Northern Committee to negotiate with NITC through TNC a reduction in class size to 25 or below. Practical class sizes should continue to be 20 or less. This class size reduction should be funded accordingly.

 - 2. To remind members of the need to record and report all incidents of violent behaviour to the union, school management and the HSENI.
 - 3. through NITC, to lobby DE to lead a campaign promoting a Zero Tolerance approach to all forms of abuse against teachers.

- a) notes that the only formal means for a teacher, including principals and vice principals, to raise a complaint against members of boards of governors is to invoke TNC 2011/4 Annex III of the Policy and Procedure to Combat Bullying and Harassment of Teachers Including Principals and Vice Principals TNC 2009/11.
- b) further notes reports of challenges faced by INTO members and officials in effectively pursuing complaints raised through this procedure.
- c) calls on Northern Committee to work, through the appropriate negotiating mechanisms, to seek the development and implementation of a fit for purpose complaints procedure, through which teachers, including principals and vice principals, can raise legitimate complaints against governors, that do not fall under the category of bullying and harassment.

MOTION 13

Conference:

- i. notes with concern that education funding in NI is in a state of crisis.
- ii. Also notes difficulties schools face with regards the procurement method for controlled and maintained schools in particular.
- ii. Calls on Northern Committee working through NITC to lobby the Education Authority and DE to reform the scope of schools to procure materials and equipment from a wider range of suppliers and are afforded greater flexibility to do so in a given year.

MOTION 14

Conference acknowledges that all pupils, regardless of their educational needs, require access to high-quality education in the most appropriate setting for their needs, supported by adequately trained staff and sufficient resources to meet their needs.

Conference notes with concern:

- a) The increasing demand for special educational needs (SEN) provision across NI.
- b) Reports of SEN students placed in educational provisions where they are not able to access a curriculum that meets their specific learning and/or medical needs.
- c) The impact of inappropriate placements on the educational experience and long-term outcomes of pupils

Conference calls on the Northern Committee to work through the NITC to:

- (i) seek the development of clear, consistent, and equitable criteria for SEN placements, to ensure that all pupils are placed in the most appropriate educational setting for their individual needs regardless of where in the North they live.
- (ii) Demand the introduction of a post-placement assessment by EPS for pupils placed in special provision classes
- (iii) Lobby the Department of Education to implement a robust monitoring system to track the appropriateness and effectiveness of SEN placements in specialist provision classes.
- (iv) advocate for teachers to receive appropriate training and professional development to equip them with the skills necessary to support pupils with a wide range of complex/diverse SEN in special provision classes.

Conference is concerned at the stress the current monthly payment system is putting on members.

Conference calls on Northern Committee through NITC to work with DE and other relevant bodies to review the monthly system and propose the implementation of a fortnightly system to ensure teachers are not struggling at peak times.

- c) calls on Northern Committee, through NITC, to seek agreed means by which all schools can avail of appropriate and timely Human Resources support.

- a) condemns the increase of paperwork required by the EA and other support services that has impacted on the ability of many SENCoS to carry out the full range of tasks attached to their post.
- b) notes the resultant budgetary pressures to support SENCoS in this role.
- c) calls on Northern Committee to work with NITC to demand that funding is made available to allow each school to have access to a non-teaching SENCo.

- b) Calls on Northern Committee to advocate for work-life balance to reduce burnout, improve retention and to enhance overall teachers' effectiveness.
